

Bladder Management

TRANSFORMING INCONTINENCE TO INDEPENDENCE









Upon successful completion of this course, attendees will learn how to evaluate and treat clients with urological disorders as well as gain invaluable tools to start bladder programs at their facility. The course will start by providing a comprehensive review of the anatomy and physiology as it relates to micturition control. This will provide a solid foundation for understanding why and how to treat clients with incontinence using a holistic approach. After learning evidence based treatments for all forms incontinence, attendees will participate in a hands on lab learning skills including limited intermittent catheterization for male and female, male external catheter management and urostomy management.

Objectives

- Describe the physiology of micturition.
- Define and distinguish the 5 types of urinary incontinence.
- Describe at least 1 non-pharmacological treatment intervention for each type of incontinence.
- Describe at least 3 adaptive tools or assistive technology to increase independence with bladder management and appropriate use of each.
- Name the three categories of urinary catheters and verbalize clinical reasoning for selecting each type.
